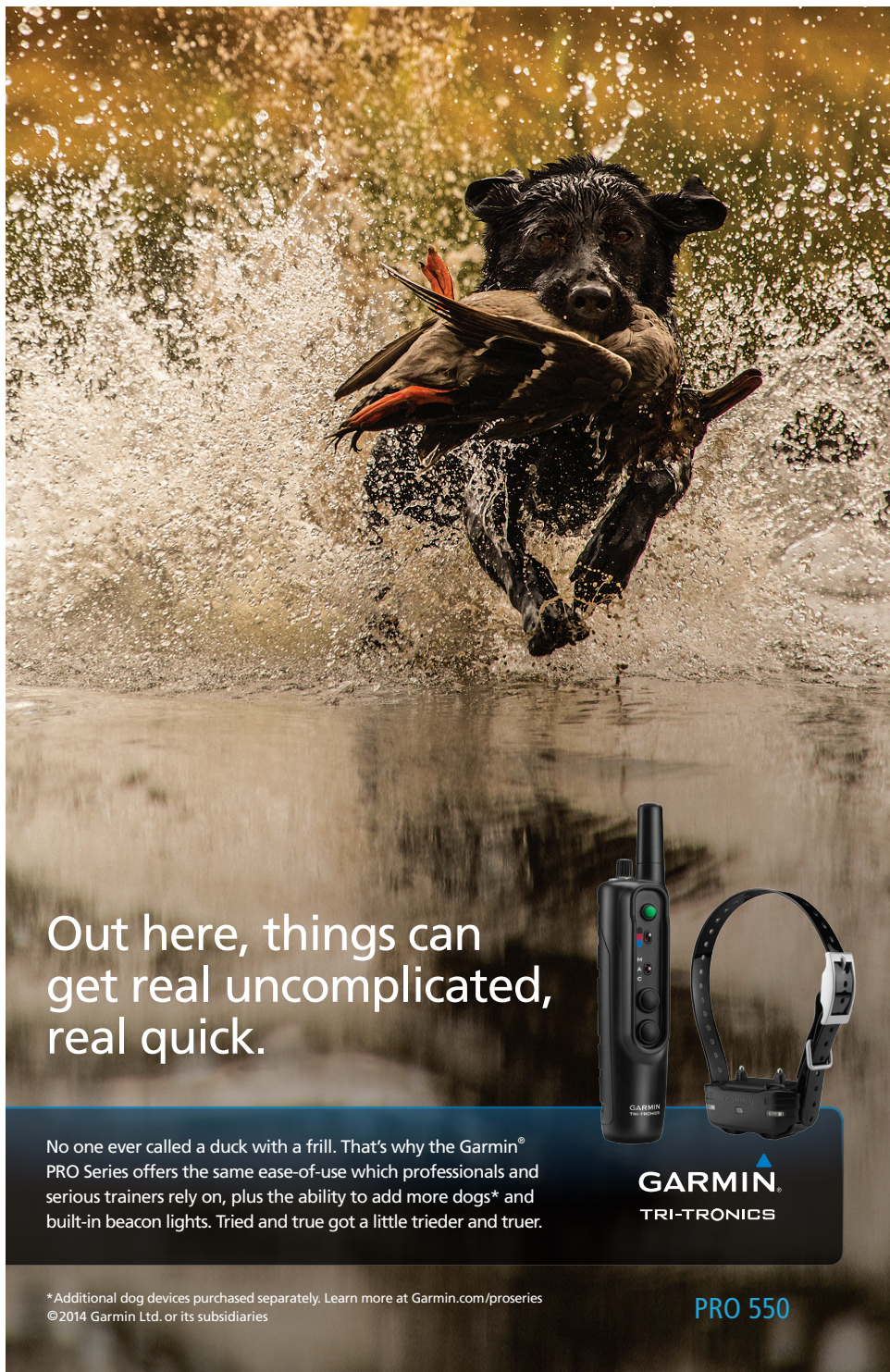

# 2015 Judge Clay Earl



My wife Karen and I live on a farm outside of Woodstock Ontario. We have developed the property to serve as a hunting dog training facility. We welcome friends and interested trainers from all over the globe to our property to share in pursuit of our interest in the training of Springers, Labradors and Cocker Spaniels for trials and hunting. We ask nothing in return from them but to treat the property, animals, and people with respect.

I was lucky enough to grow up in Saskatchewan, where there is ample access to land and game for hunting. Most of my free time was spent hunting birds and big game or training and trialing dogs. In these pursuits I have been humbled by a wild bird that gives your best dog the slip when you hit that bare piece of ground, and perplexed by that mallard that dives down to the bottom of the slough and magically disappears on your best retriever. I have smiled proudly as my young charge accomplishes what we were working on in training and watched amazed and excited as a fellow competitor's dog shows brilliance in a field trial. Through it all, I have made many friends, had a lot of fun, and learned a lot.

I have been lucky to champion dogs, place them in National trials in Canada and the USA and walk behind some very good charges. They were all different with individual strengths and weaknesses. Each taught me something and I am thankful to all of them. I have been blessed to watch some awesome performances from the judge's position and the gallery. I learned a great deal from so many fellow trialer's dogs, other handlers, and folks that I have judged with. I thank you all.

I recently turned 51 at the time of this writing and find myself having 13 dogs in our kennel; a mix of Springers, Labs, and Cockers. I never thought I would have this many dogs..... neither did my wife. It is a 4-5 hour commitment daily. Karen encourages me to pursue my passion for working with the dogs and developing training methods that will allow us to showcase their abilities. Karen is an immense aide with the kennel and on top of that load picks up the slack I have left in our production business. I thank her for all her support without which I would not be penning this Biography.

Throughout my 30 years in field trials, I have judged over 100 trials. This assignment will be my third national, having judged the Canadian National in 2000 and the US Open in 2004. My approach continues to be based on observing the performance before me, recording the information, and communicating with my co-judge to get an overall picture of the trial and individual performances.

I want to thank all competitors for the time, effort, and money you invest in pursuing the difficult sport of field trials - without you, none of this is possible. My wish for you is that you and your dog are able to accomplish personal bests. I pledge to do my part as a judge: providing you a fair opportunity to display your team, observing your work, and evaluating it in a manner that takes overall performance into account. I wish to thank the landowners, National Committee, volunteers, and all involved in putting on the 2015 National Open.

# 2015 Judge John M. Meyer



My Involvement with English Springer Spaniels began when I purchased my first puppy 37 years ago at age 13.

With my father's support I went on to successfully participate in my first field trial at the age of 14. This was the beginning of my long association with the English Springer Spaniel Field Trial community. As a youngster I spent many long hours in the field with starting puppies and helped in the training of the adult dogs by bird planting, shooting and running my own pup. Some notables in that group of dogs over the years were Hall of Famer FC AFC Bluff Creeks Shadow, NAFC FC CFC Kane's Bluff Creek Annie, and

High Point Amateur FC AFC CFC Bluff Creeks Corky. The sport of "dogs and field trialing" is something my family and I have enjoyed for more than three decades.

Over the years my role and participation in field trials has evolved from training and competing to other aspects of the sport. In my younger years I planted field trials including a National trial and as a teen I began shooting for puppy stakes. This allowed me to have the privilege of being invited to shoot in over 300 field trials across the nation including Six National Championships so far and the 2014 National Amateur in Illinois.

While judging many Puppy stakes through the early years, I also had the privilege to judge my first Open All-Age some 25 plus years ago. Since that time I have judged at least 25+ trials across the country. A recent honor was judging the Hall of Fame trial in Tennessee. With my rounded involvement in the field trial sport I have been molded as a judge by watching, participating, and of course, receiving mentorship from some of the "old guys" from the various Minnesota clubs where I watched the group grow from one active club to four active clubs.

Currently I have three Springer Spaniels, one retired, one hunter, and a new competitor who is soon to make her debut from the puppy stake to the All-age.



# STANDARD PROCEDURE FOR SPANIEL FIELD TRIALS

1. The purpose of a Spaniel Field Trial is to demonstrate the performance of a perfectly trained Spaniel in the field. The performance of a Spaniel in Field Trials should not differ from that in any ordinary day's shooting, except that in the trials a dog should do his work in a more nearly perfect way.

2. The function of a hunting Spaniel is to walk at heel (or on a leash) until bidden to seek game. When so ordered, he should seek game in a brisk, quiet manner thoroughly quartering the designated cover, within gunshot, in the line of quest without unnecessarily covering the ground twice. When game is flushed, dogs should drop or "hup" to flush or command and, if game is shot, should retrieve at command only, but not until the Judge has instructed the handler. Dogs should retrieve quickly and briskly when ordered to do so and deliver tenderly to hand. They should then drop or "hup" until given further orders. Spaniels which bark and give tongue while questing are objectionable and should be severely penalized.

3. If a dog, following the line of a bird, is getting too far out he should be called off the line and later he should again be cast back on it. A dog which causes his handler and gun to run after him, while line running, is out of control. Handlers may control their dogs by hand, voice, or whistle, but only in the quiet manner that would be used in the field. Any loud shouting or whistling is evidence that the dog is hard to handle, and, in addition, is disturbing to the game.

4. A dog should work to his handler and gun at all times. A dog which marks the fall of a bird, uses the wind, follows a strong runner which has been wounded, and will take direction from his handler, is of great value.

5. When the Judge gives a line to a handler and a dog to follow, this must be followed and the dog not allowed to interfere with the other contestants running parallel to him.

6. The Judges must judge their dogs for game-finding ability, steadiness, and retrieving. In game finding the dog should cover all his ground on the beat, leaving no game in his territory and showing courage in facing cover. Dogs must drop to wing and shot and obey all commands. When ordered to retrieve they should do this tenderly and with speed. No trials for Spaniels can possibly be run without retrieving as that is one of the main purposes for which a Spaniel is used.

7. In judging a Spaniel's work Judges should give attention to the following points, taking



them as a whole throughout the entire performance, rather than giving too much credit to a flashy bit of work.

*Control at all times, and under all conditions.*

*Scenting ability and use of wind.*

*Manner of covering ground and briskness of questing.*

*Perseverance and courage in facing cover.*

*Steadiness to flush, shot and command.*

*Aptitude in marking fall of game, and ability to find it.*

*Ability and willingness to take hand signal.*

*Promptness and style of retrieve and delivery.*

*Proof of tender mouth.*

Where facilities exist and Water Tests are held in connection with a stake, the manner and quality of the performance therein should be given consideration by the Judges in making their awards. Such tests should not exceed in their requirements the conditions met in an ordinary day's rough shoot adjoining water.

Land work is a primary function of a Spaniel, but where a Water Test is given, any dog that does not complete the Water Test shall not be entitled to any award.

8. The guns should shoot their game in a sportsmanlike manner, as they would in a day's shoot. The proper functioning of the Official Guns is of the utmost importance. The Guns are supposed to represent the handler up to the time the game is shot, although not interfering in any manner with his work or that of the down brace. They are supposed, if possible, unless otherwise directed to kill cleanly and consistently, the game flushed by the Spaniels at a point most advantageous to a fair trial of their ability, with due regard to the dogs, handlers, Judges, gallery and other contingencies.

9. Care should be taken not to shoot so that the game falls too close to the dog. If this is done it does not afford a chance for the dog to show any good retrieving ability and often results in a bird being destroyed. The Guns should stand perfectly quiet after the shot, for otherwise they may interfere with the dog and handler. When a dog makes a retrieve no other birds or game should be shot unless ordered by the Judge for special reasons. The Gun must also keep himself in the correct position to the handler and others.

10. It has been repeatedly proven that the most efficient gun and load for this work, in all fairness to the dogs, handlers and those responsible for the trial, is a well-choaked twelve gauge double gun, and a load of not less than three drams of smokeless powder, and one and one-eighth ounces of No.5, No.6, No.7 or No.7-112 shot.

11. Wearing an article of blaze orange clothing is required in the field.

# DAN LANGHANS LEGACY TROPHY

Beginning in 2016 a trophy is offered in honor of Dan Langhans and his contributions to our sport.

We all know what a fierce competitor Dan was. It was amazing to watch him work tirelessly shaping the next dog or fixing a problem that cropped up in preparation for the next trial.

He would say dogs are like a tube of toothpaste. If you squeeze too hard on one end something pops out on the other. He had many lines like that he would use to guide people who were willing to listen.

Dan took great joy in walking up and grabbing another ribbon or watching the owner take the honors for a dog that he himself so expertly handled. He also took as much joy watching someone he mentored rise to the task and accept the blue ribbon.

When you come right down to it, it was all about the next great dog, no matter who was running it. Dan's eyes would light up when he witnessed a dog that could do it all. Take a tough situation and make it gold. The very characteristics that win nationals.

So it is for this reason that a trophy meant to honor Dan Langhans will be awarded to the top dog in the country. After all, isn't that what Dan was.

This trophy is to be awarded to the overall high point dog in the country. It will be for the combined points acquired in both the open and amateur stakes during the qualifying period for the Nationals of that year. These points will be weighted based on the number of starters in each stake. The winning dog need not run in both stakes. This will allow the trophy to be accessible to all handlers. It will be a perpetual, traveling trophy that will be returned with the appropriate engraved plate honoring that year's winner for the next year. The trophy will be awarded at the latest English Springer Spaniel National of the year.

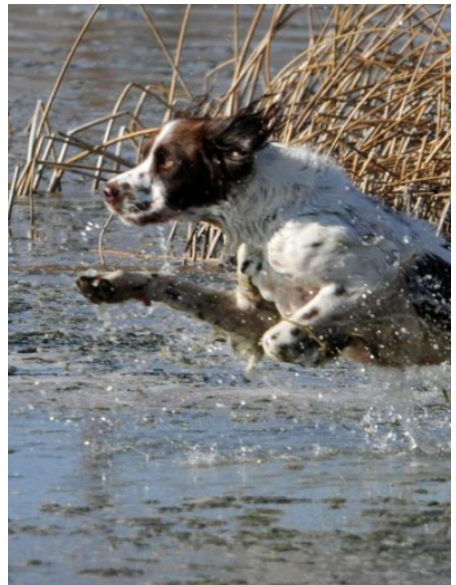

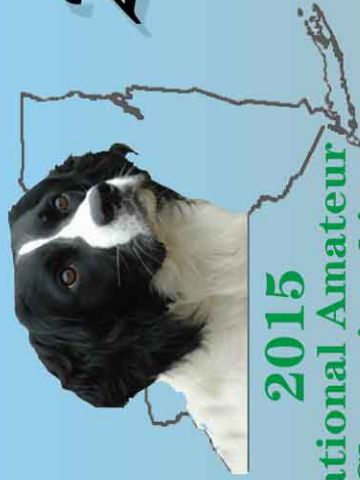

### Eligibility Criteria

- Student, or their parent or grandparent participated in ESS Field Trials (e.g., as competitor, gunner, planter, field trial chair, or field trial secretary) or served as a club officer in an AKC recognized ESS club, as an inter-club chair, or a NOC officer within the past 3 years
- Student is enrolled full time in an accredited community college, college, or university and is pursuing a postsecondary degree (associate, baccalaureate or post-baccalaureate) or certificate, or is enrolled in an apprenticeship program and pursuing trade certification or licensing
- Student displays evidence of leadership, engages in volunteer activities, and exhibits potential for a successful career
- Student has a demonstrated financial need

### Process

- Applications must be submitted no later than June 1, 2016
- Applications will be reviewed by the Scholarship Review Committee (made up of one representative from each of the five regions), who will make award decisions
- NOC President will notify applicants of award decisions no later than August 1, 2016
